## **Privacy Policy**

Our company "Choice-1-Marketing" is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

This privacy policy sets out how our company "Choice-1-Marketing" collects and uses information from all end users of our Internet services (the "Services) - those who access some of our Services but do not have accounts ("Visitors") as well as those who may purchase Products and/or pay a monthly service fee to subscribe to the Service ("Customers")- what we do with the information we collect, and the choices of Visitors and Customers have concerning the collection and use of such information. Read this Privacy Policy carefully. By visiting our Company, "Choice-1-Marketing" Web sites, you are consenting to our policy of collecting and using your data.

## Personal Information Our Company Collects and Usage

Our company collects information in different ways from Visitors and Customers who access the various parts of our Services and the network of Web sites accessible through our Service.

Purchases: Our customers who purchase or financially subscribe to our products or service are asked for personal information when purchasing our products or services including name, address, telephone number, billing information like a credit card number. Custom Audiences: These advertising platforms offer different methods to advertise to customers, potential customers, and visitors. One of the methods is through Custom Audiences. A Custom Audience is a list of people that we would like to show our ads to on these platforms who have shown interest in our service or we think they will show interest. The audience may consists of names and email addresses our company already has through collection of data in manner consistent in this privacy policy.

In the subject line put "Opt Out" and include the platform such as Facebook. In the message describe in detail the platform you would like to opt out of Custom Audience and include the email address that you want opted out. Our company will contact platform and request that your email be removed from the Custom Audience.

If you choose to opt out of our company mailing list, then email us at optout@internetpurchases.net and detail your name and email address that you want opted out of our company records. Opting out of our company records will not remove you from Custom Audiences. You need to request being removed from Custom Audiences.

Cookies: A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyze web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyze data about web page traffic and improve our website in order to tailor it to customer needs. Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

Remarketing: Our company may use cookies, Google Analytics and Google Tag Manager, Microsoft Advertising tracking codes or tags, and Facebook tracking codes and pixels to collect data about visitors and use this data to serve ads that retarget or remarket visitors and customers.

Our company may utilize various types of advertising that appear on our company sites and services including ads on third party sites and services. Our company may make use of categories of information, including names and email addresses our company has collected from customers and visitors on our sites, as well as third party sites and services, in relation with the ads that are served. These advertisements may include, but are not limited to, geo-location data, behavioral or interest based advertising, contextual advertising, tracking codes like cookies and pixels, and/or remarketing or retargeting advertising.

This is a form of advertising targeting the specific individual visiting the website.

These are all methods to collect and track visitor. This allows advertising platforms to show you advertisements across the internet and across personal devices like, but not limited to, internet browsers, smart phones, computers, tablets, and smart TVs. Our company shares end user tracking data with third parties for advertising and marketing purposes.

Our company may use "Interest Based" audience data or "Demographic Based" audience data (such as age, interests, and gender) from these adverting platforms to serve you ads based on this data.
